Eric suggests a form of "return to normalcy" by explicitly assigning roles rather than doing each task ad hoc as was done for the 2022 event, since we now have more people.

- Sponsoring: Binta and Jacopo are interested
- Logistics: Solal
- Workshops: Eric and Qinyue, at least for this Spring semester
- IT: Solal can help, especially as he already wrote the current registration system
- Marketing: Su can help, and Alina for reaching out to other universities
- Prizes: Simona
- Jury composition/handling: Alina

This leaves food as the one area not covered by anyone in particular, which also highlights the need to recruit more members.

# Acceptance of the budget

Solal presents a budget according to the discussions, inspired by previous years' budgets.

This budget explicitly plans for incomes in workshops, partnering with companies to propose workshops around their technologies

The budget for the main event is conservative in expenses, particularly as some expenses were made last year on "swag" orders for multiple years.
